Please read this letter to assist you in making disposition of the charge(s) filed against you. The Judge cannot discuss the merits of a pending judicial proceeding prior to trial (Canon 3(5). Code of Judicial Conduct..) **THIS MEANS THE JUDGE CANNOT DISCUSS YOUR CITATION WITH YOU BEFORE TRIAL.**

IF YOU FAIL TO RESPOND TO THE CHARGE(S) BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE WILL BE FILED AGAINST YOU FOR FAILURE TO APPEAR AND WARRANTS ISSUED FOR YOUR ARREST. A JUVENILE WHO FAILS TO APPEAR WITH LEGAL GUARDIAN BY THE TIME AND DATE ON A CITATION MAY HAVE THEIR LICENSE SUSPENDED AS REQUIRED BY LAW (Article 67011-4, Vernon's Texas Civil Statutes). **AN ADDITIONAL FEE WILL BE ASSESSED FOR EXECUTING OR PROCESSING A WARRANT.**

NON-RESIDENT VIOLATORS: If you have an out of state driver license and that state is a member of the Non-Resident Violator Compact, failure to comply with requirements set forth in the Citation will result in your license being suspended in your home state.

IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE, please so indicate on the reverse side in the proper space provided. A plea of Nolo Contendere means that you do not contest the state's charge(s) against you. The fine for a Nolo Contendere plea is the same as that for a plea of Guilty. Either plea indicates that you agree to waive appearance before the Court for trial. Please refer to the schedule shown below to determine the total amount of fine(s) and costs acceptable by the Court. Make your remittance by Cashier's Check or Money Order payable to the Municipal Court marked at the top of this letter. **Return your copy of the Citation and this letter with your remittance to assure proper credit.**

IF YOU WISH TO ENTER A PLEA OF NOT GUILTY and desire a trial, advise the Court by checking No. 3 on the Reply Form on the reverse side on or before the appearance date. You will be notified by the Court when to appear for trial and specific requirements of the particular court concerning bond requirements, etc.

___ I have NOT had Deferred Disposition in lieu of paying a fine during the past 12 months.
___ I am NOT in the process of taking a Deferred Disposition course to dismiss another offense.
___ I have NOT completed a Deferred Disposition course that is not yet reflected on my driving record.
___ I understand I CANNOT take the Deferred Disposition course in lieu of paying the fine if I am accused of speeding 25 miles an hour over the posted speed limit.
___ **I ENCLOSE proof of Financial Responsibility (insurance). (A photocopy is acceptable—NO ORIGINALS PLEASE!!)**
___ **I ENCLOSE a money order or cashier's check made payable to the Municipal Court indicated on the reverse in the amount of \$106.00.**
___ I understand that I am responsible for completing a D.P.S. approved Deferred Disposition Course and remitting the proper completion certificate to the Court before the expiration of the 90 day extension.
___ I understand that this form must be NOTARIZED.

Once the 5 requirements have been met, it is up to the defendant to locate the school and register. **YOU WILL NOT RECEIVE ANY CORRESPONDENCE OR FORMS FROM THIS COURT.** The request must be received by the Court on or before the due date on the Citation. You have 90 days from the due date to provide the Court with the original Certificate of Completion for the Deferred Disposition Course.

FAILURE TO APPEAR IN COURT, or FAILURE TO SATISFY A JUDGEMENT ORDERING THE PAYMENT OF A FINE AND COST IN THE MANNER ORDERED BY THE COURT MAY RESULT IN THE DENIAL OF RENEWAL OF YOUR DRIVER'S LICENSE.

2. IF YOU HAVE COMPLIED WITH ALL THE REQUIREMENTS ON THE OTHER SIDE, YOU ARE ELIGIBLE FOR THE COURSE AND ARE RESPONSIBLE FOR COMPLETING AN APPROVED COURSE AND REMITTING THE COMPLETION CERTIFICATE TO THE COURT BEFORE THE EXPIRATION DATE OF 90-DAY EXTENSION.

SCHEDULE OF MINIMUM ACCEPTABLE FINES

1. SPEEDING
 - A. Begin with \$120.00 base fine and add \$4.00 for each mile over speed limit \$120.00
 - B. 26 mph or more over Speed Limit Call the Court
2. Crossing Physical Barrier \$175.00
3. Defective Lights, Brakes, or Equipment \$155.00
4. Disregard Traffic Control Device \$155.00
5. Drive From/Onto Controlled Access Highway Where Prohibited \$155.00
- *6. Expired Driver's License – Charges may be dismissed if Defect is remedied within 10 working days \$125.00
- *7. Expired Vehicle Registration – Charges may be dismissed if Defect is remedied within 10 working days \$125.00
8. Expired Vehicle Inspection Certificate – Charges may be dismissed if Defect is remedied within 10 working days \$135.00
9. Failure to Report Change of Address \$105.00
10. Failure to Signal or Unsafe Lane Change \$180.00
11. Failure to Drive in Single Lane \$155.00
12. Failure to Dim Headlights \$135.00
13. Failure to Yield Right-of-Way \$180.00
14. Fail to Control Speed or Unsafe Speed \$180.00
15. Following to Closely \$205.00
16. Use of Unapproved Sunscreening Device \$195.00
17. Illegal, Unsafe, or Improper Turn \$180.00
- *18. No Valid Driver License or Valid Motorcycle License \$175.00
 (Charges will be dismissed upon presentation of a valid driver's license, provided the license was valid at the time citation was issued)
19. No Motorcycle License Endorsement \$125.00
20. No Liability Insurance \$375.00
 (Charges will be dismissed upon presentation of evidence that insurance was in effect on the vehicle driven on date of arrest)
21. Permit Unlicensed Driver or Minor to Drive \$175.00
22. Passing or Overtaking Violation \$305.00
23. Safety Belt Violation (Driver or Passenger) \$145.00
24. Safety Belt Violation Child \$205.00
25. Violate Drivers License Restriction \$125.00
26. Wrong Side of Road (Wrong way on One-Way) \$280.00
27. Parked Without Lights \$180.00
28. Passing or overtaking School Bus \$355.00
